



## DEPENDENCY OVERRIDE PETITION 2009 - 2010

The Higher Education Act of 1992 defines those students who are considered independent of parental support for educational costs. These rules are explained in the Free Application for Federal Student Aid (FAFSA Step Three). If you do not meet the definition of an independent student under these rules, but believe that you are truly independent, the Northwest College Financial Aid & Scholarships office may consider, under Professional Judgment, exceptional circumstances which would allow you to be considered “independent” for purposes of federal financial aid.

These circumstances are unique and are reviewed on a case-by-case basis. Situations such as parental unwillingness to provide support, parents no longer claiming the student as a dependent on their federal tax return, and the maintenance of a separate residence by the student from parents are **not considered extenuating circumstances.**

The financial aid administrator may allow an override of dependency status on the FAFSA, if warranted, based upon unusual situations. Special circumstances that may be sufficient for consideration of an override include:

- Severe circumstances such as an abusive home situation, history of parental alcohol or drug abuse, abandonment by, both parents or incarceration of custodial parent.
- Death of a parent after filing the FAFSA and the surviving parent meets one of the conditions listed above.
- You are divorced, under 24 years of age and do not have children. You maintain a residence separate from your parents and pay all living expenses with your own income and assets. Please attach a copy of the divorce decree and receipts/documentation to show self-support.
- Other exceptional circumstances not described above.

You must provide documentation to the satisfaction of the financial aid administrator that you are truly self-supporting in order to obtain a dependency override.

**\*\*You must complete this process each year until you are considered “independent” by the U.S. Department of Education’s definition\*\***

- 2) Provide a complete history, for the last year, of where you have lived and document sources of income and support.
- 3) Attach to this form; two letters confirming your situation (from foster parents, social-worker, clergy, counselors, etc.).
